Linfoflu[®] is a food supplement containing lactoferrin, resveratrol, beta-glucan, vitamin C and arginine. Some of these substances may be lacking in the bodies of certain individuals.

Lactoferrin is a multifunctional glycoprotein belonging to the transferrin family, found mainly in colostrum and breast milk. Together with the other ingredients, it contributes to the correct functioning of the immune system.

Resveratrol is a polyphenol produced by plants and found in nature in the skins of red grapes, raspberries, mulberries, blueberries and in the root of the plant *Polygonum cuspidatum*.

Beta-glucan is a purified polysaccharide extracted from baker's or brewer's yeast (*Saccharomyces cerevisiae*).

Vitamin C contributes to the reduction of tiredness and fatigue and to the protection of cells from oxidative stress and, together with zinc, it contributes to the normal function of the immune system.

Arginine is an essential amino acid which is vital for the growth of children, since they are not able to synthesise it effectively, as adults do.

Linfoflu[®] has a pleasant black cherry flavour which is very popular with children. Gluten-free. Naturally lactose free.

INDICATIONS

Useful in all cases of reduced intake or increased need for the nutrients contained in Linfoflu[®]. *Vitamin C contributes to the reduction of tiredness and fatigue and to the protection of cells from oxidative stress and, together with zinc it contributes to the normal function of the immune system.*

DOSAGE AND INSTRUCTIONS FOR USE



One vial daily as a single dose, preferably on an empty stomach.

To take the product fully screw the cap of the vial clockwise as far as possible, so that the content of the cap will fall into the liquid.

Shake vigorously and drink immediately.

WARNINGS

Food supplements should not be regarded as a replacement for a varied and balanced diet and a healthy lifestyle. Do not exceed the recommended daily dose. Keep out of the reach of children under three years of age. Consult your doctor before giving the product to children under three years of age.

Store in a cool and dry place, away from light and direct heat sources. The validity period refers to the product correctly stored in unopened packaging.
